Right to Life-LIFESPAN is gratified by the letter signed and sent by seventy two members of the House of Representatives to the Presidents, Chairmen and CEOs of ABC, NBC and CBS, taking them to task for their lack of reporting on Planned Parenthood of Florida's apparent approval of the killing of babies who survive the abortion process and for the total lack of reporting on the murder trial of Kermit Gosnell, whose actions as a late-term abortion provider have been described as brutal and murderous and his "clinic" as a "house of horrors"
