

Legislative Update

Michigan Pro-Lifers Pursue Ballot Measure to Stop Tax-Funded Abortions

Michigan pro-lifers are pursuing a ballot measure to stop taxpayer funding of abortions in the state. The measure is necessary because Governor Snyder vetoed a bill that would stop taxpayer financing of abortions under Obamacare.

At a meeting on May 22, Michigan's Board of State Canvassers approved the **No Taxes for Abortion Insurance** petition form. More than 258,000 valid signatures from registered voters will now need to be collected in order to prevent Michigan from subsidizing abortion coverage in insurance plans.

The Board of State Canvassers approved the group's petitions for a statewide ballot initiative. If they can get the required 258,088 valid voter signatures, the proposed law could be adopted by the Legislature or put before voters in 2014.

Right to Life is pursuing the legislation after Gov. Rick Snyder vetoed a bill last year that changed the legal structure of Blue Cross Blue Shield of Michigan and included requirements from the Republican-controlled Legislature that residents cover additional insurance to cover aborting pregnancies.

"People that are in favor of abortion would have to purchase that insurance," said Barbara Listing, president of Right to Life of Michigan. **No Taxes for Abortion**, the ballot committee, has 180 days to collect signatures and can start that process anytime during the next year.

If the Board of State Canvassers determined the group collected enough valid signatures for the proposed statute, the Legislature would have 40 days to either adopt the law or allow it to go on the ballot, said Fred Woodhams, spokesman for Secretary of State Ruth Johnson.

Rebecca Kiessling, a pro-life attorney based in Michigan, supports the effort and says it is also due in part to the desire to protect babies who are aborted after they are conceived in rape.

"The petition drive is to override Governor Snyder's veto of the opt-out of abortion coverage in Obamacare," she explained to LifeNews.

"Governor Snyder had issued a letter at the end of December stating that he vetoed the bill because it did not have a rape exception."

"Right to Life of Michigan tried to convince Governor Snyder to pass the bill without an exception but he refused. Therefore they decided to embark on this very costly endeavor of collecting 258,088 signatures within 180 days, which Right to Life of Michigan is confident they will achieve. This sets a great example to the pro-life movement that the least of these are worth fighting for," she said.

Kermit Gosnell Receives Third Consecutive Life Term

A bortion practitioner Kermit Gosnell received his third consecutive life prison term on May 15, this one for the baby he killed in an abortion-infanticide he said was so big it could “walk to the bus.”

Gosnell was convicted of first-degree murder in the deaths of three babies born alive after an abortion process that involved jabbing them in the neck with scissors. On May 14, Gosnell gave up his right to appeal the verdict that found him guilty on three of the four first-degree murder charges he faced. As a result, prosecutors agreed to two life terms in prison and Gosnell would not face the death penalty.

On May 15, Gosnell faced sentencing for killing a woman in a failed abortion. Gosnell was also sentenced to two and a half to five years in prison for that and will spend the rest of his life in prison.

The prosecutors originally sought the death penalty because Gosnell killed more than one person and because of the age of the newborn babies involved. They also agreed to the life sentences in prison because Gosnell’s age made it unlikely he would be executed before his appeals ran out, as he would die naturally beforehand.

Gosnell’s attorney, Jack McMahon, said the abortionist accepts the verdict and isn’t sorry he went to trial. He said Gosnell gave up a somewhat better deal early on but wanted to air the issues in court and is satisfied that he did so.

“He wanted this case aired out in a courtroom and it got aired out in a courtroom in a fair way. And now he’s accepting what will happen. He’s an intelligent guy,” said McMahon, who said Gosnell would now plead to federal drug charges that are still pending.

Gosnell was found guilty of killing Baby A, Baby C and Baby D and found not guilty of killing Baby E. He was also convicted on hundreds of lesser charges ranging from infanticide to running a corrupt organization.

Gosnell was also found guilty of involuntary manslaughter in the death of patient Karnamaya Mongar, who died after a botched abortion. And he was found guilty on most of the more than 200 counts of violating Pennsylvania’s informed consent law.

In total, Gosnell was found guilty of 21 out of 24 felony counts of illegal abortions beyond the 24 week limit and found guilty on all but 16 of 227 misdemeanor counts of violating the 24-hour informed consent law.

Below are the details related to the four babies Gosnell was charged with killing:

Baby Boy A was the biggest baby that Kareema Cross had ever seen delivered at Gosnell’s abortion “House of Horrors” clinic in the four years she worked there. He was delivered to 17-year old Shaquana Abrams at 29.4 weeks gestation, according to an ultrasound record.

Baby Boy A was so large, he did not fit into the plastic shoe box that Gosnell tossed him in. Cross said she saw the baby pull in his arms and legs while Gosnell explained the movements as “reflexes” telling her the baby really didn’t

move prior to cutting the baby’s neck.

Baby Boy A was so large, Gosnell joked that “this baby is big enough to walk around with me or walk me to the bus stop.” Cross and fellow employees Adrienne Moton and 15-year old Ashley Baldwin were all so “startled” by the size of the baby that they all took photos of the baby with their cell phones.

Baby C was an intact baby of over 25-weeks gestation. Kareema Cross testified that she saw Baby C breathing and described the up and down chest movements she observed for 20 minutes. She told the court she saw Lynda Williams lift the baby’s arm and watched as the newborn drew it back on its own power.

Afterwards, Williams inserted surgical scissors into the baby’s neck and “snipped” the spinal cord. Gosnell was said to be in the room at the time. This baby’s murder charges were unintentionally dismissed in the place of Baby F, but were reinstated after Judge Minehart discovered his error.

Baby D was described by witnesses as 12-15 inches long with the head the size of a “big pancake” when he was delivered into a toilet. Kareema Cross testified that she saw the baby struggling, using swimming motions in an attempt to get out of the toilet bowl. Adrienne Moton pulled the baby out and “snipped” the neck, as Gosnell had taught her to do, while the mother watched.

Gosnell has also been charged with Criminal Solicitation of Moton to commit murder of Baby D.

Baby E was estimated to be at least 23 weeks gestation and maybe more. After Baby E was delivered, teen Ashley Baldwin heard the baby cry and called Kareema Cross for help. Cross described the baby’s cry as a “whine.” Baldwin said that Gosnell when into the room then came out with the baby—which now had an incision in its neck—and tossed it into the waste bin.

Eight other defendants who are former staffers of Gosnell’s Philadelphia abortion clinic have pleaded guilty to a variety of charges and are awaiting sentencing.

Previously, the judge in the case reinstated one of the murder charges and dropped another. Gosnell’s defense attorney asked the judge to drop three of the charges for killing the babies and the judge agreed with the contention there was not enough evidence to convict Gosnell on those charges. Another charge of infanticide was also dropped.

One of the dropped charges involved a 28-week-old baby Gosnell killed and whose remains were kept in an abortion clinic freezer.

Scientists Claim They Have Cloned Human Embryos for Stem Cells



Researchers in Oregon claimed they have succeeded in producing cloned human embryos and obtained their embryonic stem cells.

They have engaged in the grisly research with the goal of producing genetically matched stem cells for research and possible therapies—even though embryonic stem cells have never helped human patients and cause tumors when injected.

The Oregon Health & Science University scientists published a paper on May 15 in the online journal *Cell* reporting on the use of cloning techniques to produce human embryos, 21 of whom they were able to sustain to the point in development at which stem cells were present, after which the human embryos were killed and the stem cells harvested.

Leading pro-life advocates quickly condemned the clone and kill methods that destroyed unique human beings.

“These researchers created many human embryos, male and female, and allowed them to grow for up to seven days, for the sole purpose of killing them and harvesting their stem cells,” said NRLC Legislative Director Douglas Johnson. “We will certainly continue to oppose attempts in Congress to provide federal funds to create human embryos for the purpose of harvesting their cells—which is a step towards human embryo farms.”

Johnson said current federal law (the Dickey-Wicker Amendment) prohibits the use of federal funds to create human embryos. Bills to authorize the use of federal funds for such purposes have been proposed in Congress in the past.

The chairman of the Committee on Pro-Life Activities of the U.S. Conference of Catholic Bishops also condemned the cloning and said human cloning for any purpose is inconsistent with the moral responsibility to

“treat each member of the human family as a unique gift of God, as a person with his or her own inherent dignity.”

“Creating new human lives in the laboratory solely to destroy them is an abuse denounced even by many who do not share the Catholic Church’s convictions on human life,” said Cardinal Seán O’Malley, OFM Cap., of Boston.


He said this way of making embryos will also be taken up by people who want to produce cloned children as “copies” of other people. “Whether used for one purpose or the other, human cloning treats human beings as products, manufactured to order to suit other people’s wishes.” He added, “A technical advance in human cloning is not progress for humanity but its opposite.”

He added that the researcher’s goal of producing genetically matched stem cells for research and possible therapies is already being addressed by scientific advances that do not pose the same more problems.

He said: “The news that researchers have developed a technique for human cloning is deeply troubling on many levels. Over 120 human embryos were created and destroyed, to produce six embryonic stem cell lines. Creating the embryos involved subjecting healthy women to procedures that put their health and fertility at risk. And the researchers’ alleged goal, producing genetically matched stem cells for research and possible therapies, is already being addressed by scientific advances that do not pose these grave moral wrongs.”

I Was Raped and Left Pregnant at 17, But I Love My Baby

I've been there. Not Todd Akin. Not Richard Mourdock. And certainly not their critics who sanctimoniously imagine that they know what pregnant sexual assault victims really want and need.

As my story shows, all too often, our self-appointed champions do more harm than good.

I was 17, drugged and raped. When I learned I was pregnant, my family, counselors and doctors took control.

They intended the best. They wanted to help me. And even though there are literally no studies showing any benefit from abortion, they had total confidence in the social myth that abortion is the best option, even the *only* option, in cases of sexual assault.

Even many pro-lifers approve of abortions in cases of rape. So surely it must be the best choice, right?

Not in my case. It just added more layers of trauma, self-doubt, grief and guilt. The negative impact lasted for years.

I'm not alone.

A national study published in 1996 found that half of the estimated 32,000 rape pregnancies which occur each year end in abortion. Note: *half*. Not even 60 percent.

That so many women choose to give birth after rape, despite the social expectations and pressure to abort, should give you pause. Why aren't all rape victims embracing the conventional wisdom that abortion is the best treatment for rape pregnancies?

A hint is found in another study of 164 women who had rape pregnancies (conducted for the book *Victims and Victors*). In that study, the majority of those who had abortions said it only caused additional problems and the vast majority regretted having abortions. By contrast, among those who delivered the child, satisfaction was higher and none stated any regret for giving birth.

Why are these facts so little known? It is because many people on both sides of the abortion debate are more concerned with their ideologies than they are the complex nitty-gritty details which confound sound bites.

Because the actual experiences of pregnant sexual assault victims have not been widely heard, the social myth that abortion is the best, or even the only, option in cases of rape pregnancies is almost universally accepted. This universal myth creates its own set of problems for women.

When a pregnant sexual assault victim balks at having an abortion, she will almost immediately face queries of suspicion from family and friends. How can any woman have a rapist's child, they wonder? And then the suspicion mounts...maybe she lied. Maybe she was not really the victim of a "legitimate" rape?

And so the assumption that surely a real rape victim would want an abortion creates a new pressure on hurting women, in a time of intense crisis, to accept the recommendation of abortion, despite moral qualms and heightened sensitivity to victimization, to swallow their reservations and have the abortion if only to silence the rising doubts about their rape story.

I hope I've convinced you that the rape and abortion issue is not as simple as you've always assumed.

This is why I have joined the Ad Hoc Committee of Women Pregnant by Sexual Assault (WPSA). For eight years, we have been petitioning Congress to hold hearings to allow us to describe our own experiences, insights and needs.

It is our hope that policy makers, the media and well-intentioned people on all sides of the abortion debate finally hear the truth from those who have been there. Only when our voices and experiences are included in future discussions and arguments over rape, incest and abortion will those discussions and arguments be less blatantly ignorant and hurtful.

Whatever side of the abortion debate you are on, I hope you'll agree that our voices should be heard. Please call your representative and senators and ask them to endorse our petition.

It's time to replace posturing with knowledge. And in this case, knowledge can come only from those who have actually been there.

Gosnell, whose squalid “house of horrors” abortion clinic has surprised even investigative officials, has had an almost flippant attitude toward his macabre abortion practices that have shocked the nation.

“The Gosnell case is a watershed moment for the issue of abortion,” said Troy Newman, President of Operation Rescue and Pro-Life Nation. “The discovery of his horrific practices helped shed light on an abortion industry that has run amok without oversight or accountability for decades, and has prompted significant changes in abortion laws and attitudes toward enforcement in several states.”

Previously, Gosnell’s wife Pearl pleaded guilty to assisting her husband at his Philadelphia abortion center where he killed a woman in a botched abortion and has killed hundreds of babies in abortion-infanticides. Pearl Gosnell was considering a plea deal similar to the one several of Gosnell’s former abortion center employees have made where they have pleaded guilty to receive a lesser sentence in exchange for testifying against Gosnell.

Pearl also worked at the abortion center Gosnell ran that had him kill and injure women in failed abortions and kill perhaps hundreds of babies in grisly infanticides by birthing them and “snipping” their spinal cords. She worked at the Women’s Medical Society abortion business her husband ran as a full-time medical assistant from 1982 until she married Kermit Gosnell in 1990, when she switched to only working on Sundays.

At that time, the abortion business was officially closed but would do its latest-term abortions possible. The grand jury report indicates Pearl Gosnell testified that she alone helped Kermit do abortions on Sundays when she would “help do the instruments” in the operating room despite no medical training.

The murder charges also came in connection with the botched abortion death of 41-year-old [Karnamaya Mongar](#), who died at Gosnell’s abortion clinic after a failed abortion. Mongar died November 20, 2009, after overdosing on anesthetics prescribed by the doctor.

Mongar’s family filed a lawsuit against Gosnell’s abortion business seeking damages. Gosnell and several staffers at his abortion center, including Pearl, were arrested in January after a grand jury indicted them on multiple charges after officials raided his abortion business following a woman’s death and discovered a “shop of horrors” filled with bags of bodies and body parts of deceased unborn children and babies killed in infanticides.

Meanwhile, women have spoken out about their treatment and one woman says she was drugged and tied up and forced to have an abortion. Authorities searching the facility found bags and bottles holding aborted babies scattered around the building, jars containing babies’ severed feet lining a shelf, as well as filthy, unsanitary furniture and equipment.

The grand jury investigation also shows state officials did nothing when reports came in about problems at Gosnell’s abortion center, which has upset incoming pro-life Governor Tom Corbett.

Gosnell’s abortion center was inspected only after a federal drug raid in 2010. It was the first time the facility had been inspected in 17 years because state officials ignored complaints and failed to visit Gosnell’s Women’s Medical Society for years.

The abortion industry has been forced to suspend two abortion businesses that employed embattled abortion practitioner Kermit Gosnell, who has been the subject of national controversy over his abortion business in Philadelphia.

Networks Give Angelina Jolie 27 Minutes 56 Seconds for Gosnell Verdict

ABC and NBC led their morning shows on May 14 with nearly 10 minutes of “breaking news” coverage of Angelina Jolie’s double mastectomy. This celebrity-driven story was apparently deemed more important than abortionist Dr. Kermit Gosnell being found guilty of three counts of first-degree murder, as *Good Morning America* and *Today* devoted just 38 seconds to the Gosnell trial.

Altogether, the ABC and NBC morning newscasts aired 19 minutes and 3 seconds of coverage on Jolie. Tuesday’s CBS *This Morning* waited 12 minutes to cover the Hollywood news item, but ultimately ended up setting aside 7 minutes and 49 seconds of air time to the surgeries, versus a 18-second news brief on Gosnell.

The total Big Three coverage of Jolie on May 14, including CBS’s reporting, added up to **26 minutes and 52 seconds**, as opposed to **56 seconds** on the Gosnell case.
