## Drug companies & stem cell research

In April of this year, *The Wall Street Journal* reported that some large corporations such as Becton, Dickinson and Company, Invitrogen Corp. and Johnson and Johnson plan to conduct stem cell research using days old embryos. General Electric Co. and the U.S.-based headquarters of the Swiss drug giant Novartis AG may also begin research programs involving human embryos.

Because embryonic stem cells have yet to produce any treatments or cure any patients, large corporations have mostly stayed away from the stem cell research area.

Other drug companies such as Eli Lilly and Co., GlaxoSmithKline and Baxtor do not use embryonic stem cells. WSJ, Merck and Company purchased some embryonic stem cells, but destroyed them before using them and company policy prohibits its scientists from using them.

## American Cancer Society and human embryonic stem cell research

Are you wondering about the positions of certain organizations or associations with regard to pro-life issues and whether or not you should donate to them? You can e-mail the particular organization and ask specifically or query its websites' search feature for particular issues. Printed below is the American Cancer Society's position on embryonic stem cell research.

*The American Cancer Society has supported, both in its written formal testimony and in oral testimony, the proposed National Institutes for Health (NIH) guidelines for scientific research using human embryonic stem cells. The Society believes that such research holds extraordinary potential in the fight against a variety of life-threatening diseases currently afflicting an estimated 140 million Americans. The American Cancer Society also believes that the Federal government remains the institution best suited to both fund and oversee research using human embryonic stem cells. The Society commends the Administration for allowing this vital scientific research to proceed - even in a limited way. For its part, the Society — with its tightly targeted niche research focus and limited financial research resources — has consistently expressed a willingness to contribute to the exploration of stem cell research by funding investigations into the specific efficacy of human adult stem cells or umbilical cord blood. The American Cancer Society remains hopeful that both the government and commercial sectors will continue to work collaboratively and with an open mind to explore additional solutions that will allow for the continuation of human embryonic stem cell research as necessary and appropriate.*

## National Organization of Women & choice

As everyone knows, NOW has been a leader in assuring that every woman has the right to choose. Pro-lifers know

that "the right to choose" is a code word for the right to abortion. According to NOW president Kim Gandy, it appears that the right to choose is not total.

During a three-day meeting held by the Food and Drug Administration to discuss lifting the 13-year-old ban on silicone gel breast implants, groups such as NOW and the Feminist Majority Foundation lined up to demand that the FDA keep the ban. When the panel recommended by a 5-4 vote to continue the ban, Gandy called it a "tremendous victory for women's health." Those women who had testified that they wanted the ban lifted insisted that they should have the "right to choose" what to do with their own bodies. When confronted by a woman insisting that "women need choices," Gandy responded, "Choice? The choice is to be sick."

It would seem that some women's organizations think that the only choice women can make for themselves is the choice to destroy their own child.

## "Yew" gotta wonder!

The following item appeared in a special issue of *Newsweek* magazine, Summer 2005, devoted to "Your Health in the 21st Century."

"The discovery of Taxol (ed note: used in the treatment of breast cancer), derived from the bark of the Pacific Yew tree, set off a debate in the late 1980s. Should we destroy forests to save lives? In the end, scientists found a substance in the stems and needles of the European Yew that could be made into Taxol."

Let's see if we understand this. A debate raged about the ethics of cutting down trees to save human life, but pro-life people are told we are wrong, cruel and unreasonable when we object to the destruction of human embryos for experimentation. It is hard to believe, but it seems that yew trees are held in higher regard than human life when it comes to medical experimentation.

## **Infant Protection Compliance**

The Bush administration is planning to check nationwide compliance with a federal law that requires health care professionals to provide proper medical care for newborns who survive botched abortion attempts. Reports have surfaced that some hospitals are not following the law.

In 2002, President Bush signed the Born Alive Infants Protection Act after a Chicago-area nurse discovered staff at her hospital were allowing newborns to die after failed abortions.

In May, 2004, it was reported that babies were being left to die in some Florida hospitals. It was thought that some hospitals may not be aware of the new law, the first pro-life bill approved since the *Roe v. Wade* decision legalized abortions.

In addressing the problem, Mike Leavitt, secretary of HHS said he would "vigorously" uphold the law. "We took the first of these educational steps today by notifying relevant entities that we aggressively enforce federal laws that protect born-alive infants." Leavitt explained, "We issued clear guidance that withholding medical care from an infant born alive may constitute a violation of federal law." Leavitt vowed to "investigate all circumstances where individuals and entities are reported to be withholding medical care from an infant born alive in potential violation of federal statutes."

## **The Filibuster "Compromise"**

In order to stop the constant and prolonged filibuster of President Bush's judicial nominees, Republicans had threatened to change the number of Senators needed to close a filibuster. (Filibusters are generally reserved for legislative efforts—the judicial filibusters were a way to prevent judicial candidates from receiving the up or down vote required by the constitutional mandate for the U.S. Senate to "advise and consent" to Presidential offerings.)

In order to head off what was considered by some to be a dangerous change to Senate procedure, a compromise was reached.

Senator John McCain (R-AZ) announced the terms. "We have reached an agreement to try to avert a crisis in the United States Senate and pull the institution from a precipice that would have had, in the view of all 14 of us (committee formed to study the issue) lasting impact, damaging impact on the institution."

The compromise averts the change in Senate rules on filibusters in exchange for a promise to not filibuster judicial nominees, except for "extraordinary or extreme circumstances."

As with many compromises, not everyone was pleased with the outcome. President Bush indicated that he expected all candidates to get an up or down vote. "My job is to pick people who will interpret the Constitution, not use the bench from which to write law," he said.

The key objection is that there is no definition for "extraordinary circumstances" or "extreme" candidates. The fear is that those in opposition to the president's philosophy could name any potential high court candidate as "extreme" and institute a filibuster anyway.

Judges William Pryor, Priscilla Owen and Janice Rogers Brown have been, or are expected to be, approved by the entire Senate now that the filibusters against them will be ended.

The next challenge will come when Mr. Bush nominates judges to the Supreme Court.

## **Embryonic Stem Cell Research**

The U.S. House of Representatives has approved two measures concerning taxpayer funding of embryonic stem cell research. HR 810 (Stem Cell Research Enhancement Act of 2005) would require federal taxpayer dollars to be used in such research. HR 810 was introduced by Michael Castle (R-DE). Michigan co-sponsors were

Joe Swartz, Sander Levin, Carolyn Kilpatrick, John Conyers and John Dingell. The measure passed 238-194, with Michigan Representative Fred Upton joining the Michigan co-sponsors in an affirmative vote. The measure was opposed by Michigan Representatives Camp, Ehlers, Hoekstra, Kildee, Knollenberg, McCotter, Miller, Rogers and Stupak. The measure now moves to the senate.

At the same time that HR 810 was introduced, Representative Chris Smith(R-NJ) and Representative Artur Davis (D-GA) introduced HR 2520 (C.W. Bill Young Cell Transplantation Program). This measure would create a new federally funded stem cell therapeutic and research program for the collection and inventory of umbilical cord blood. Michigan co-sponsors were John Conyers and Thaddeus McCotter. Such cells are considered adult stem cells and have a proven record of treatments and cures. The measure passed 431-1 with two not voting. The measure now moves to the Senate.

President Bush strongly opposed HR 810 which, he says, "would compel all American taxpayers to pay for research that relies on the intentional destruction of human embryos for the derivation of stem cells." The statement from the White House made it clear that Mr. Bush would veto HR 810 if approved by Congress. On the other hand, the President strongly supports HR 2520.

## Ultrasound Images at Abortion Clinics

In May, State Representative Dave Robertson (R-Dist 51) introduced a measure to the Michigan House of Representatives (HB 4446) which would require abortion businesses to allow women considering an abortion to see ultrasound footage of their unborn child. The measure was co-sponsored by, among others, Representatives Garfield, Palmer, Gosselin, Taub and Pastor.

Governor Granholm and the ACLU oppose the measure as does Planned Parenthood of Michigan. A spokesperson for Planned Parenthood stated that most women do not want to see

ultrasound pictures of their babies. Since no woman would be required to see the ultrasound image, this objection does not seem terribly serious.

A poll, commissioned by CareNet and conducted by The Polling Company, found that, of 802 registered women voters, 87% said that it is important for non-profit women's health centers to provide ultrasound services.

The measure now moves to the Michigan Senate.

## President Bush and the Abortion Rate

In an opinion piece found in the web and e-mail publication of *Sojourners*, a Christian magazine, in October, 2004, Glen Harold Stassen, an ethics professor at Fuller Theological Seminary claimed that the incidence of abortion had climbed during the presidency of George W. Bush. In the article he stated, "Under President Bush, the decade long trend of declining abortion rates appears to have reversed." "Given the trends of the 1990s, 52,000 more abortions occurred in the United States than would have been expected before this change of direction."

Politicians such as Hillary Clinton, Howard Dean and John Kerry quoted the Stassen article at length, sometimes indicating that there had been a 25% increase in abortions under President Bush.

Now comes a study by The Alan Guttmacher Institute (the research arm of Planned Parenthood) of 43 states that show that abortions have actually decreased under President G. W. Bush. It was determined that Stassen used incorrect data, included only 16 states in his research and did not allow for the fact that two of those states had recently changed their reporting methods, causing a statistical increase and even used the birth rate instead of the abortion rate in one state.

Though rebutted by pro-life advocates days after its release, the Stassen article was widely quoted, even appearing in the Letters to the Editor of the *Michigan Catholic*. Now Mr. Stassen concedes that the Guttmacher study, "is significantly better" than his own.

There has been no comment on the Guttmacher findings by those who quoted the original Stassen analysis.

## Senate Committee Hearing on Abortion Previews Supreme Court Battle

In light of a potential battle over a possible nominee to the Supreme Court, a Senate panel held hearings on June 23 on the effect of one of the high court's most contentious decisions—*Roe v. Wade*. The former Roe in the case testified on abortion's effect. Norma McCorvey, the former Jane Roe of the infamous case that legalized abortion, became pro-life years ago. She shared that story and the tale of pro-abortion attorneys who used her plight to overturn pro-life laws. McCorvey was a single mother with drug and alcohol abuse problems who found herself pregnant again. She wanted a divorce, not an abortion, but Texas attorney Sarah Weddington chose to use her case to junk a state law prohibiting most abortions. "Instead of getting me financial or vocational help, instead of helping me to get off drugs and alcohol, instead of working for open adoption or giving me other help, my lawyers wanted to eliminate the right of society to protect women and children from abortionists," McCorvey said. Now a pro-life advocate who has tried to have the courts overturn the original case, McCorvey told her story to members of the Senate Judiciary Committee, which would be the first battleground in any fight over a Supreme Court pick. That battle could begin as early as the week of July 3, when Washington insiders say Chief Justice William Rehnquist, who was one of two judges dissenting in the *Roe* case, plans to retire. —*LifeNews.com*, June 27, 2005

## Do not push gently into that good night

I have spent most of the past three weeks inside a hospital room, watching a person I love fight for his life.

It is in this frame of mind—raging helplessly against the ever-mutating cleverness of disease, how hungrily and with such stealth malignancy hovers, circles, teases, even retreats just long enough to kindle hope—that I come, with outrage, to the reignited debate of assisted suicide.

Torn from the current headlines, it's a trendy issue. But morally hollow. So profoundly abominable that it provokes in me a fury I can barely control.

Death is never a mercy. To characterize death as merciful is to invest it with nearly altruistic qualities, with tenderness, which is a kind of anthropomorphizing, as if death has a personality and we can alter its features, render it more kindly, make of it even a friend.

Merciful death—it was for the best...at least he's not suffering any more—is but a shallow platitude, seized upon most eagerly by those who cannot otherwise admit their own relief in being released from the exhausting burden, emotional and otherwise but essentially vicarious, of illness and infirmities and frailty; of how awful life looks, wasting and desiccated and necrotic, when it's trickling away.

This is, I think, the unbearable heaviness of being.

Of growing old and feeble, or not even so old but terribly sick, losing one's faculties, one's mobility, one's mind—reverting, yes, to the helplessness of infancy. But it is inevitably the healthy who recoil from this, as if even death were a preferable alternative to such dependency and deterioration.

We project our revulsion—which is essentially rooted in fear of our own mortality—and convince ourselves that somebody else would be better off dead because look, just look, at how wretched their existence has become or will become. And that says a great deal about the value that we subtract from a life when it is no longer vigorous and productive; when it just lies there, maybe thinking, maybe dreaming, maybe remembering.

Little wonder that the sick and dying begin to see themselves as valueless, too, abhorrent, ashamed, unworthy because they can no longer walk or talk or feed themselves.

It is precisely the lame, the enfeebled and the despondent who most need our protection, our gentling, to assuage their pain and respect the essence of their being. This essence is not held hostage to the ravages of the flesh.

A mother who helps a son take his own life—as that misguided woman in Montreal last week, her son just 36 and only in the early stage of multiple sclerosis, is charged with doing—has, if she did it, committed both a crime and a grievous sin. Suicide is the murder of self. Assisted suicide is just plain murder, however some might rationalize it as a supreme act of compassion.

It takes gall—or guile—to call what this woman did selfless love.

She must not be absolved for it, out of mercy.

There's an immense difference between declining to apply extraordinary life-extending measures—respecting do-not-resuscitate orders—and intervening not merely to hasten death but to inflict it. Abetting suicide in the irreversibly ill or

the utterly incapacitated is not a kindness; it's an abuse of power.

This young Montreal man was not incapacitated, although he was surely depressed, and chronic depression crushes reason. He had an illness that couldn't be cured, that would assuredly get worse. But he wasn't in insupportable physical pain and he could have lived a productive life—one that contained pleasure and curiosity and wisdom—for decades, with MS, as have hundreds of thousands of other Canadians.

What he needed was a professional to treat the sadness and fatalism that had settled in his bones. The last thing he needed was a mother in emotional thrall to his deranged thinking or seduced by his need to bail prematurely from an envisioned existence he could not, in that agitated state of mind, bear to contemplate.

Don't speak to me about opinion polls that show most Canadians favour a legal option for helping someone to die. This is not a question that can be posed in the abstract, and then answered in the affirmative by those not immediately or imminently facing that acute, bewildering, agonizing dilemma. The young and the healthy are in no position, certainly shouldn't be, to tilt the debate on the depth of their beautiful, enviable ignorance. More illuminating, more intuitively informed, are the views of physicians and palliative care professionals and those involved with disabled people's organizations who are, in the main, strongly opposed to both euthanasia and assisted suicide.

Do not harm is the core code of doctors. That is the antithesis of beckoning death.

It is not in our nature to truly imagine ourselves, or those we love, at the fraying end of the mortal coil. We're only pretending, and the real thing isn't like pretending at all. We might think we know what we'd want for ourselves or for those we care about, but believe me, we do not. I've seen enough of dying—in all its grotesque manifestations and most especially in those who never saw it coming—to have learned that nobody, no mentally lucid human being, is ever eager to depart this world.

It is indeed different for those who aren't lucid, for those in unspeakable pain, and those so intractably depressed that life doesn't seem worth living. But physical pain can nearly also be effectively managed, in this advanced society, and those unable to think clearly should not be making this most irreversible of all decisions for themselves.

Killing the terminally ill or the dreadfully enfeebled must never become the expedient thing to do, dressed up as pity. It must not be legislatively condoned, even that we know full well that it happens in furtive ways, sometimes with physicians involved. There are occasions when it's better to leave some things unexamined.

The moment we condone murder—assisted suicide—even for those just tenuously still attached to life, we set ourselves upon a wicked path, one where the worth of a person is measured empirically. Assisted suicide begets euthanasia and a society that makes intellectual peace with euthanasia is one that puts at risk every human being in it, but most especially the constituency of the vulnerable: The grievously ill, the chronically ill, the mentally ill, the unproductive, the economically draining, the recidivist, the subversive. Maybe you, maybe me.

I put my hand to my father's cheek—but only when he's sleeping because we are not a family that touches—and I feel the warmth of a living person. I feel a heart beating for all the damage that's been done to it. Not even the stench of gangrene assaulting my nostrils can occlude the sweetness of life still being lived. I am so pitifully grateful for every day, for every minute, for every breath.

It's the sadness that must be borne. Sadness and anger and impotence and fatalism—all the emotions that combine to plant in a person's mind the seductive belief that it's better to rush toward death in one final damn-you rebel yell, an assertion of individual will. As if to say, I am the master of my fate.

None of us is. And none of us will make it out alive.
