VOTER SURVEY

Lifespan sent the following nine-question survey to each candidate for Governor, U.S. House of Representatives, Michigan Senate, Michigan House of Representatives, Appeals, Circuit, District and Probate Judicial offices, County Commissioner and various local city and township offices in Wayne, Oakland, Macomb and Livingston Counties.

1. The 1973 U.S. Supreme Court *Roe v. Wade* decision allows for abortion for any reason, even as a method of birth control, even in the late stages of pregnancy. Do you **SUPPORT** the reversal of this decision?
2. Do you **SUPPORT** a law banning partial-birth abortions, except to prevent the death of the mother?
3. Some public funds are used for abortions or abortion referral. Do you **OPPOSE** the use of public funds for abortion or abortion referral, except to prevent the death of the mother?
4. Human embryonic stem cells and human fetal tissue are used in some medical experimentation which has no beneficial effects for the fetus. Would you **SUPPORT** legislation that would prohibit the use of embryonic stem cells and fetal tissue in such experiments?
5. Would you **SUPPORT** a law banning so-called “reproductive cloning”—cloning meant to result in the birth of a baby?
6. Knowing that the removal of stem cells from human embryos results in the death of those embryos, would you **SUPPORT** a law banning so-called “therapeutic cloning” (somatic cell nuclear transfer)?
7. Do you **OPPOSE** laws allowing assisted suicide?
8. Do you **SUPPORT** honoring the wishes of patients who want life-saving treatment (including food and water) regardless of their degree of disability, age and “quality of life”?
9. Do you **SUPPORT** legislation that would protect health care professionals from being forced to distribute medications or provide medical care that violates their moral or religious beliefs?

NOTE: Lifespan is not a political organization and does not endorse candidates for election. We have surveyed the candidates as a service to our members. Absentee ballots

According to Michigan law, you are eligible to vote by absentee ballot if one of the following applies:

You are 60 years of age or older; you will be out of town on election day; you prefer to vote absentee because of illness, physical disability or religious tenets; you are confined to jail awaiting arraignment or trial; you are an election precinct inspector in a precinct other than the one where you reside.

To get an absentee ballot simply call or write to your city, township or village clerk and ask for an absentee voter application. Or, apply in person to the clerk and fill out a standard form. If you want the ballot mailed to you, your application must be received by 2:00 p.m. on the Saturday before an election date. Your vote must reach your local clerk before the polls close on election day at 8:00 p.m.

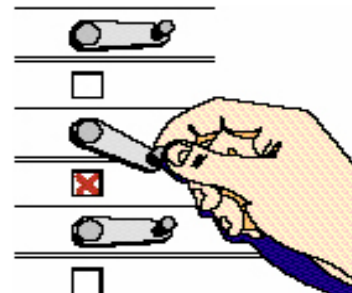

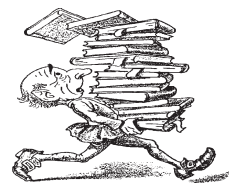

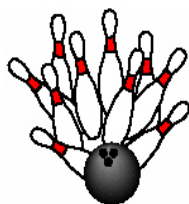
Book learning

They were shocked that abortions can be done through the entire nine months of pregnancy, and that unborn babies feel pain. After their visits with us, they must give an hour presentation to their classmates on what they had learned at LIFESPAN.

They contacted Rebecca Kiessling whose mother was raped and Rebecca was the child survivor from that rape. Rebecca visited the school with her four young children (who were wonderful while their mom talked). She was allowed twenty minutes to tell her story. Laurie and I were there. You could hear a pin drop as Rebecca spoke. Most of them had never heard or seen someone who had been conceived in rape, and they listened attentively to her message!

Christina and Amanda continued to share with their classmates what they learned while visiting LIFESPAN. They acknowledged that they were pro-choice when we first met. They really didn't know what an abortion was. They told the class that when you substitute "killing an unborn child" for the word abortion, you realize what happens when abortions are performed. They revealed that they were now pro-life, and would like to visit LIFESPAN again to help!
