With the passing of Justice Antonin Scalia, the nation lost a brilliant legal mind, a steadfast defender of the Constitution and a true conservative.

To the consternation of many, he clearly stated that the right to an abortion was found nowhere in the Constitution and, along with dozens of legal experts, felt that the Roe v Wade decision of 1973 was improper. He maintained, from a legal view, that allowing for abortion was clearly a matter for each individual state to decide and that the Court erred in finding such a right within the Constitution.

At a time when so many challenges to the Constitution are being brought before the Supreme Court, his voice for the rule of law will be sorely missed.
