

## **News Notes**

### Hudson's, Mervyn's, Target...

We are thrilled to pass on the great news that Target Corporation, formerly known as Dayton Hudson Corporation, and which includes Dayton's, Mervyn's Hudson's, Marshall Field's and, of course, Target stores, is no longer on the Life Decisions International boycott list as a corporation that supports Planned Parenthood. (Planned Parenthood operates the nation's largest chain of abortion facilities.)

More information will be forthcoming in Life Decisions *The Caleb Report*, and we will pass those details on to you in our next newsletter.

Thank you for making this victory possible!

More good news—the Harley-Davidson Corporation is also no longer a boycott target.

### This is a good "F!"

According to Kate Michelman, president of the National Abortion and Reproductive Rights Action League (NARAL), Michigan ranked dead last out of all 50 states in offering abortion services. Because there are only 36 abortion clinics in just 11 of Michigan's 83 counties, NARAL gave us an "F." (For comparison, there were 70 abortion clinics in Michigan in 1992.) We do good work!

### When is a child a child?

In the last few days of his time in office, Bill Clinton allowed a regulation to the Protection of Human Research Subjects statement of Health and Human Services.

In this rule, are some definition changes. One of these includes calling a baby after birth a "fetus" until it is determined she will live by "independently maintaining a heartbeat and respiration," and only when this determination is made is the baby considered a "child" under this HHS regulation.

Several pro-life representatives, including Jim Barcia (D-MI), sent a

letter to Secretary Tommy Thompson, indicating that, "If this rule is allowed to proceed, the position of the federal Department of Health and Human Services with regard to "human research subjects" will be that babies born alive are not necessarily children. This cannot and should not be the position of an agency tasked with defending children and protecting life." The rule, scheduled to go into effect March 19, 2001, has been delayed for 60 days.

### Culture of life

In a ceremony to inaugurate the Pope John Paul II Cultural Center in Washington, D.C., President George W. Bush lauded the Pontiff and his support for a "culture of life."

"The culture of life is a welcoming culture, never excluding, never dividing, never despairing and always affirming the goodness of life in all its seasons," Bush said before an audience of cardinals, bishops, clergy and laymen. "In the culture of life, we must make room for the stranger."

"We must defend in love the innocent child waiting to be born," he said in defense of the Catholic Church's pro-life stance. Bush, a Methodist, praised the pope as "never more eloquent than when he speaks for a culture of life."

This drew a burst of applause from the audience who rose from their seats for a long ovation. Only a few, including Senator Edward Kennedy (D-MA) who opposed Bush's reinstatement of a ban on taxpayer funding of groups that promote or perform abortions overseas, and his niece Caroline Kennedy Schlossberg, remained in their seats. Schlossberg's husband's New York based firm created the interactive, educational exhibits at the Cultural Center, which aims to help visitors explore questions of spirituality through simulations and exhibits.

### Granholm restricts use of RU-486 in Michigan

Known as the abortion pill and mifepristone, RU-486, has been under wide scrutiny since it was approved by the FDA last September. Call it what you like, but Michigan Attorney General Jennifer Granholm still calls it abortion.

Granholm issued her opinion March 13 in response to Michigan Department of Community Health Director James Haveman's question of whether RU-486 constitutes an abor-

Granholm, a Democrat, cited the Social Welfare Act, the Parental Rights Restoration Act and the Public Health Code in determining that "the intentional use of mifepristone to terminate a woman's pregnancy for a purpose other than to increase the probability of a live birth, to preserve the life or health of the child after live birth, or to remove a dead fetus, and not as a contraceptive, constitutes an 'abortion.'"

As regulated by the state, women under the age of 18 who wish to have an abortion must have permission of one guardian or a judge, and they must receive information designed by the state, including pictures of fetal development at least 24 hours before the abortion.

A Students for Choice spokesperson, Jennifer Anderson, said Granholm's recent opinion puts more restrictions on women, and this is a curious stance for a pro-choice attorney general. She speculated that it may have been a political decision considering the state's Republican governor and Legislature.

University of Michigan Students for Life President Andrew Shirvell said he is pleased with Granholm's opinion. "We view this as a positive change that Michigan views [RU-486] as a form of abortion. Her ruling is correct—it should be regulated under the same rules as a surgical abortion," he said. "It's very different from other forms of contraception. The job of the pill is to expel the fetus from the uterus."

### Death of an Unborn Child

By votes of 32-0 in the Senate and 84-21 in the House, the Michigan legislature has approved a law that would make it a felony, punishable by life in prison, to assault a pregnant woman with the intent of killing an embryo or fetus. The bill now goes to Governor Engler, who is expected to sign it.

The bill was opposed by some groups. Planned Parenthood spokesperson, Judith Karandjeff, spoke in opposition to the bills on the grounds that they might have implications on a woman's right to abortion. "This legally separates a woman from her fetus," she said, and might have the effect of conferring "personhood" on an unborn child.

The law was prompted to close a loophole in the Michigan law that provides for a felony charge for assaulting a pregnant woman with the intention of causing a stillbirth or a miscarriage.

Michael Fletcher, convicted of killing his wife, Leann, was to have been charged in the death of their unborn child. The charge was dropped when it was determined that Leann had not actually given birth.





### **Mexico City Policy**

On his second day in office, by way of an Executive Order, President Bush restored the "Mexico City Policy," first put in place by former President Reagan in 1984. It remained in effect during the first Bush presidency but was rescinded, by Executive Order of Mr. Clinton on his third day in office.

The policy requires that private overseas organizations, to be eligible for funding under the U.S. population control aid program, must agree not to perform abortions (except to save the life of the mother, or in cases of rape or incest), and not to "actively promote abortion as a method of family planning"-for example, by campaigning to weaken or repeal the pro-life laws of foreign nations—either with U.S. funds or any other funds. In other words, if they promote abortion by means of counseling, perform abortions or work to change laws in the foreign country, they would be ineligible for U.S. money. It is not unusual for the government to attach conditions on organizations receiving tax money from the

One population official, expressing his outrage at the policy, actually explained it quite well. He said, "It is not about protecting federal money from abortion. It is really about being completely anti-abortion and trying to do everything you can to sabotage any organization that is in any way promoting abortion."

Expressing their anger and disgust over President Bush's reinstatement of the Mexico City Policy that prohibits U.S. tax dollars from going to family planning organizations that counsel, promote or provide abortions, Senator Barbara Boxer (D-CA) and Rep. Nita Lowey (D-NY) have introduced legislation, the Global Democracy Promotion Act, that would not make such organizations ineligible for U.S. aid, "solely on the basis of the health or medical services they offer," as long as they don't violate the laws of the U.S. or of the country in which they are being provided.

Opponents of the policy are also considering invoking the Congressional Review Act that permits the House and Senate to pass legislation rejecting regulations issued by federal departments and agencies.

### Capitol Hill battle lines

Congress will debate a number of abortion bills this term. Among them:

- Rep. Ileana Ros-Lehtinen, (R-FL), has introduced legislation that would make it a crime for anyone other than a parent to transport a minor across state lines for an abortion.
- Rep. Lindsey Graham, (R-SC), introduced a bill that would make it a crime when a fetus or embryo is injured or killed in a violent crime against a pregnant woman. Under current law, only the woman is recognized as a victim of a violent act. Sen. Mike DeWine, (R-OH), is expected to introduce similar legislation.
- Bills sponsored by Sen. Tim Hutchinson, (R-AR), and Rep. David Vitter, (R-LA), would require that a physician prescribing RU-486 be authorized to perform abortions and have admitting privileges at a nearby hospital, restrictions the FDA does not require.

### **Legislative Liaison**

We thank **Jim McLaughlin** for his service to Lifespan as our Legislative Liaison since January, 1998. Jim was instrumental in changing the mind of at least one legislator to the pro-life cause. He visited Lansing and testified before different committees on pro-life legislation. He developed a good rapport with the legislators and they welcomed him.

We will miss Jim, although he will continue to be active in Lifespan and continues as church representative at St. Linus.

We wish to welcome **Mark Cabrera** as our new Legislative Liaison. He will be promoting support for pro-life legislation and promoting defeat of pro-abortion and pro-euthanasia legislation in the Michigan Legislature and U. S. Congress.

Mark is no stranger to politics as he helped in his brother's campaign against a pro-abort encumbent state representative. Although unsuccessful in the race, the Cabrera family gave her a good fight.

Mark is vice president of Empire Financial Mortgage in Canton. Mark and his wife, Rendie, have a four-year-old daughter and a baby due in April. Mark has lived and worked in New York and Los Angeles as a song writer and producer. Mark agreed to become our Legislative Liaison because he wants to serve Christ in this way.

We both know that the "truly" wonderful people here, are our children's birthmothers. Without them, we would not have the family we had always wanted and had prayed for, for so long. Very importantly too, we know that both of our birthmothers may have even been encouraged by at least one person to just go and

have an abortion and simply get rid of their difficult situation but they did not. Instead, they chose to love the babies growing inside of them and gave them life.

Not only did they choose to give their babies life in a society that wrongly believes death is an acceptable solution to problems, but they also had the strength and courage to give them the kind of life that they knew they couldn't, through the option of adoption. Though our birthmothers may have easily or automatically chosen life for our children, we know for certain that their decisions to make adoption plans were not easy in any way. They were decisions filled with heartache and tears, along with a special strength and selflessness that many people wouldn't have, but which enabled them to make such a tremendous personal sacrifice for the sake of their children. Sure, it was easy for my husband and I to welcome a precious newborn baby into our home with open arms, especially after years of our own heartache and frustration. We were able to leave the hospital with our bundle of joy while our birthmothers had to leave with empty arms and undeniable feelings of grief from their deep loss. We can only hope and pray that God will bestow upon them peace and happiness just as they have brought to us.

God worked a miracle in our life through them, and that is wonderful. This makes them wonderful too. They gave our children life (instead of death) and so unselfishly entrusted them to our care forever. May we always remember and pray for the birthmother—that "wonderful person"—the next time we congratulate someone on the adoption of a child. That child may not have all he or she has or maybe even be alive, if it weren't for one special giver of life!

So what happens when the clone you ordered is not the person you expected? Will you be able to send it back? Could we have the ultimate two-tier society, where "types" society favors are reproduced while those seen as burdens are aborted? Or, in the Third World, left to die of curable diseases?

The peril lives in renegade scientists making these decisions on our behalf. While some countries have banned cloning, others haven't, leaving many scientists free to play God—without the permission of the human race. Secrecy surrounds the area because many scientists are terrified that public opinion will go against them.

...A U.S. poll found that three out of four people objected to cloning to allow infertile couples to have children or clones created to save the life of the person cloned. Nine out of 10 were against cloning to allow gay couples to have children, or parents to re-create a lost child, or to create genetically superior human beings. If ever there was a case where mankind needed to get together internationally and form a worldwide policy, this is it. But we couldn't stop the atom bomb or genocide, could we?

# Touched by the Truth

t's remarkable how a fantasy-based, sometimes sappy TV show featuring angels disguised as ordinary folks can pack more profound truth into one hour than a month of nightly news programs! That's precisely what writer/producer Martha Williamson accomplished in a recent episode of Touched by an Angel called "The Empty Chair." Bucking the Hollywood establishment and its "prochoice" ethic, Ms. Williamson displayed unmatched courage and insight into the aftermath of abortion.

As newlyweds in Boston, Betsy and Bud Baxter wanted nothing more than to work together on a television show. An offer from an Omaha station to cohost "Breakfast with the Baxters" seemed their first big step on the road to fame and happiness. Fifteen years later, when new station owners abruptly cancel their show, the Baxters are devastated by the loss of their jobs, of their dream, of all that had given their life meaning, and, apparently, of all that had been holding them together.

They bitterly vent their disappointment and grief at each other until the arrival of stranded travelers (the angels Monica and Andrew) give Betsy and Bud the chance to tell their stories separately to a compassionate listener. It's not long before the underlying problem surfaces—the unspoken issue that stood between them since accepting the Omaha job: that the only child they'd ever conceived was "lost" shortly before moving there.

When Betsy learned of this pregnancy, she spontaneously bought a little baby jumper. Bud reacted negatively to the news. He thought only of how a child could disrupt their career plans on the eve of their first big break. When Bud left for several days to attend a friend's wedding, Betsy dutifully took care of the problem with an abortion. She told Bud only that she had "lost" the child.

Betsy tried to conceal her grief, submerging it in work. The sorrow and pain did not go away, but silently, stealthily robbed her of joy, of sleep, of the ability to feel close to her husband, of the ability simply to relax and open herself to life.

Bud is torn between wanting to know if their child was aborted and wanting to avoid the question, to protect Betsy and himself from painfully confronting what they had done. Bud struggles to forget, and bristles at the first hint of a discussion of their loss.



His reaction is common; surveys have shown that up to 80% of marriages/relationships end in the months following an abortion. With dawning understanding, however, Bud tells Andrew: "Ironic, isn't it? You make all these plans for the future and then one day it's the wrong future and you don't have what you sacrificed for."

Betsy has always understood the full weight of the sacrifice she made for the sake of their marriage and their career: "You know, Monica, they can talk all they want about politics and choices and rights. I did. And then you're in that room and you're putting your clothes back on and you know that when you walk out that door, you're leaving a piece of your soul behind that you'll never get back."

Overly dramatic? Time and again, women who've experienced abortion, describe a similar wrenching loss of part of themselves, their spirit or their soul. (Numerous examples can be found at www.hopeafterabortion.com, a website supporting the Project Rachel post-abortion ministry.)

Post-abortion anguish can be seen websites. many www.afterabortion.com, for example, predominantly "pro-choice" women try to support each other in their grief. This site even contains a section called Media Warnings-programs and movies to avoid because some situation or remark in them could break through post-abortion coping mechanisms to trigger emotional and psychological crises. Warning entries seem to include everything relating to babies, happy families and, of course, abortion.

Betsy has wrongly concluded that a lifetime of sorrow is simply "the price you pay" for aborting a child. Monica gently corrects her: "It's the consequence of a choice, but it's not a punishment from God. That's not how He works." Monica reminds Betsy and Bud of the truth that so often eludes those involved in an abortion: God cherishes them and does not reject them for having rejected His gift of a child. He asks only that they open their hearts to Him, so He can heal them and make them whole again. God wants them to find consolation and joy in His love and in their mutual love for Him and one another.

How was Martha Williamson able to give flesh and life to this essential truth, and all the hurt and sorrow, the anger and lashing out, the loneliness and terror of the abortion aftermath? The episode was inspired by her own experience following an abortion. Through post-abortion counseling, she has found for giveness and peace—and she offers this story so women contemplating abortion will seek a life-affirming solution for themselves and their children.

# Cloning is a threat to our humanity

he Raelians are a U.S.-based cult preparing the human race for the arrival of superior aliens. They boast of funding scientists who will be the first to clone a human being, perhaps this month. In an appeal to human sympathy, Raelians plan to resurrect a dead 10-month-old boy and place him in his grieving parents' arms.

The Raelians promise the very thing Christianity promises through faith—eternal life. But they promise the reverse also—to create lives acceptable to them. And who decides whose life is acceptable? And how will the Raelian miracle baby feel when he finds he was not welcomed into the world as his unique self but as a copy of someone else? The competition to be the first scientist to clone a human is our decade's version of the moon race. Perhaps this year Neil Armstrong's "one step for mankind" will be echoed with the first steps of the first cloned baby. What we won't see are the thousands of deformed rejects.

Human cloning is the Pandora's Box of the 21st century. On the surface, comparing those who seek to destroy life with those who wish to create it seems ludicrous. You cannot compare the noble intentions of the cloning industry with those of mass murderers. However, what these self-appointed gods have in common is the folly of believing that they have a right to make decisions for the rest of humanity.

And there is always the risk that not all cloning scientists will have noble intentions. One of those hoping to be the first to clone a baby is Italian doctor Severino Antinori who pushed ethical boundaries when he enabled a 62-year-old woman to become a mother through embryo implantation. By offering infertile men an alternative to donor sperm, the opportunity to spawn their own genetic stock, Antinori convincingly presents himself as a compassionate life-creator. Who dares argue?

On an emotional level, it makes sense to do all that is medically possible to help an infertile couple have a child.

Intellectually, however, we need to ask whether everything in life can be fixed. Sometimes we have to live with infertility, just as with death. Are the needs of a minority of infertile couples worth the risk of turning humanity into a lucrative product line? When we accept that people are products rather than individuals we change our definition of what it is to be human. At worst, we are de-humanizing everyone by making each and every one of us replaceable.

Grieving parents of dying children are already collecting tissue samples for future cloning. This puts our entire concept of life and mortality up for grabs. Because what makes us human is our need to come to terms with mortality, our need to grieve and to accept the random nature of who lives and who dies.

To be human is to be a unique creation based on chance: the attraction between two people and the genes coming together with a roll of the DNA dice. With cloning, the father sees the birth of his twin. While we imagine this happening in the context of warm family relationships, the potential reality is that those who don't want to bother with relationships may narcissistically re-create themselves. Single women who become pregnant with donor sperm are already doing this to a degree.

Children's rights are never discussed in this context. If a child is cloned to provide bone marrow for a sibling with leukemia, we are assuming we have the right to conceive a child not out of love, but out of need. How will such children feel when they discover that it was their marrow, and not them, that was desired?

Children die. We die. Resurrection by harvesting a woman's egg and inserting into its nucleus the DNA of the person being copied, only brings back a copy-cat body and certain genetically based personality traits. Those who favor cloning argue that clones would be no more like or unlike their hosts than twins are. Personality is about 50% genetic and 50% environment. Even identical twins inexplicably differ in their personalities.
