



#### A question of right or life

An article published by the *Michigan Catholic* on June 29th, written by John Rosengren of the Catholic News Service accuses its readers of being guilty of the execution of Timothy McVeigh.

At the same time a piece in a local church paper accused the pro-life movement of a curious silence in the face of the federal execution of McVeigh, strongly asserting, "You are either totally pro-life or you are not pro-life!" On the heels of the McVeigh controversy, there appears to be a growing movement among both the churched and the unchurched to abandon capital punishment.

In order to clear whatever heavy air lurks around the pro-life movement, let us recall the recent past that brought us to this movement.

The pro-life movement rose from grass roots around the country by numerous peoples who believed that the mysterious child in the womb was a sublime gift from the same God who made heaven and earth. The Supreme Court decision in 1973, Roe v. Wade, declared that every mother had a legal right to have that same child destroyed. Immediately following, Doe v. Bolton extended that right to virtually the nine months of pregnancy. It is now 28 years later and it is reported that 40 million nascent children have been so destroyed.

(Aside from the human reactions to the above is the practical consideration that 40 million potential taxpayers have been summarily dropped from the rolls and neither do they pay Social Security.)

A cursory reading of the Bernard Nathanson books, (he who was once known as "the abortion doctor") reveals that, in order to produce a *Roe v. Wade* and a *Doe v. Bolton* a veritable army of brilliant activists stormed the country for years to turn the minds of the powerful to the "need" for destroying the unwanted in the womb. On the heels of their successes, a burgeoning disregard for persons already

born has produced such phenomena as child abuse by parents, school shootings by children and a Timothy McVeigh.

But, to return to the McVeigh execution and to the growing push to abolish capital punishment: *Time Almanac*, 2001 reports that 39 states still retain capital punishment. One of these permits hanging.

The pro-life movement burst on the consciousness of this nation in 1973 to answer *Roe*. It has since broadened its base to the 50 states where the carnage in abortion clinics still goes on. Should it now turn aside from protection of the innocent to focus on the 39 states who refuse to protect the guilty?

#### Stem cell research

The president's recent decision on embryonic stem cell research has created quite a stir. It seems that no one is really completely happy with the decision, which is usually the case when a compromise is reached, but there is one thing that we must not overlook. Mr. Bush emphasized that he would increase funding in the areas of adult, umbilical cord and placental stem cell research. This is extremely important. The mainstream media has done little reporting on this research, probably because there is no controversy surrounding it. Research using these types of stem cells is 5-10 years ahead of proposed embryonic stem cell research. Scientists have found ways to collect these stem cells, have encouraged them to grow and have found that some of these types of stem cells do indeed become whatever tissue is sought. There is still much that must be considered when speaking of embryonic stem cell research. It is good to know that proven research will continue. Perhaps this research will become so beneficial that the desire for embryonic stem cells will diminish.

#### Partial-birth abortion

Opposition to partial-birth abortions has gone underground since a Supreme Court decision last year struck down a Nebraska ban on them.

On June 28, 2000, the Supreme Court struck down a Nebraska late-term abortion law in *Stenberg v. Carhart*. The bitterly divided 5-4 ruling claimed the law imposed an undue burden on a woman's "right" to abortion and was supposedly so broadly written that it could ban any and all abortions.

"I don't think by any stretch we've disappeared from the scene," said prolife Senator Rick Santorum (R-PA) who introduced a bill banning the procedure last year. "We still think this is horrible."

Santorum and other pro-life advocates are rewriting partial-birth abortion bans to ensure they stay within the constitutional boundaries of the *Stenberg* ruling yet actually ban partial-birth abortions.

"The statute has to be rewritten to be more specific about what procedure is prohibited," said James Bopp, legal counsel for the National Right to Life Committee. "We have not yet recommended what we think is a proper approach to this matter. When we do, these bills will continue to enjoy overwhelming public and legislative support."

Congress passed bills in 1996 and 1998 banning partial-birth abortions, but President Clinton vetoed them, claiming they go against a woman's health.

President Bush has said he will sign a ban, but pro-life leaders in Congress have a formidable hurdle—the Senate.

"It may be more difficult to get it through the Senate with the Democrats now in control," said Jonathan Entin, who teaches law and political science at Case Western Reserve University in Cleveland. "There are people who feel very strongly about this decision, and the fact that they lost a Supreme Court case doesn't mean they are going to give up."

#### Carhart reinstated

LeRoy Carhart, the abortion practitioner who successfully challenged

Nebraska's ban on partial-birth abortions before the U.S. Supreme Court, was reinstated to his volunteer faculty position by the University of Nebraska.

The medical school in Omaha reinstated Carhart after he agreed to drop his lawsuit against the university. However, it is unclear what, if any, duties he will have.

Last summer, acting on a lawsuit filed by Carhart in 1997, the U.S. Supreme Court voted 5-4 to strike down Nebraska's partial-birth abortion ban.

Carhart sued the university after his dismissal from the school last year. He alleged the university terminated his position because of political pressure after the Supreme Court decision and news reports on how he was supplying fetal tissue from abortions for research at the school.

#### Justices deal setback to right to die movement

Family members may not withdraw feeding tubes from conscious but severely brain-damaged loved ones unless they clearly show that the patient would have wanted to die, the California Supreme Court held on August 9.

The unanimous ruling was a blow to the right-to-die movement and a defeat for the California Medical Association. It will probably affect thousands of patients, including alzheimer's and stroke victims, who are conscious but unable to communicate their wishes. Tens of thousands of such patients linger in hospital beds nationwide.

Unless these patients have left specific written instructions or designated a surrogate decision maker, their legal conservators may not remove lifesustaining tubes without "clear and convincing" evidence that they would have wanted to die or that death would be in their best interest, the decision said. Life support still can be withdrawn from people who are unconscious—in a vegetative state or a coma—without clear evidence of their wishes. The decision affects those who

retain consciousness but have little, if any, awareness of their environment.

"The impact of this decision is that a number of people who are disabled will not have to fear that HMOs and managed care will be able to make decisions about them without it clearly being in their best interest," said neurologist Vincent Fortanasce.

#### Surrendering to euthanasia means accepting less of life

The Dutch parliament's decision to legalize euthanasia reverses a universal attitude of respect for the process of death and dying, traditional in the Western societies for more than 2,000 years. For the first time in recorded history, a country has decided to sanction in law, as a reasonable act, the deliberate taking of a human life.

These events expose a deep fault line in our society defined by divergent notions of the human person and the value of suffering. Advocates of euthanasia argue that there can come a time when life becomes too difficult, suffering too burdensome, and when death—on my terms, when I want—is the only reasonable option in those extreme circumstances, and always taking proper safeguards, to relieve suffering by putting the person out of his or her misery may be the most compassionate response. What possible harm can be done by acting to end the life of a fellow human being in these circumstances?

Confronted by these tough questions, we might feel compelled to relent, to admit that, yes, a life like that should be erased. As a medical oncologist, I have struggled with the hard cases from time to time, yet I can conclude only that deliberately to take the life of a dying patient, even in trying circumstances, is a deeply pessimistic and ultimately harmful attitude for patients, doctors and society at large. Suffering is always an intensely personal experience. We can never presume to understand fully what drives persons to euthanasia, but we can know that persons who

suffer deeply are extraordinarily susceptible to external influences. They may be depressed. They may simply be lonely. We need to acknowledge that persons who suffer have their own unique and vitally important contribution to make to society. By inviting us to relieve their suffering, they can help us learn to be human, to be generous with our time and talents, never to be indifferent to the needs and frailties of others. In this way, the sick and suffering can help civilize a society that each day seems less and less human.

Doctors and nurses are privileged witnesses of those raw human experiences that so often bring out the best and the worst in us and our patients. Suffering may elicit contradictory responses of courage or fear, anger or serenity, hope or despair, selfishness or magnanimity. There is probably no better window into the human heart than suffering. But to witness the affliction of others is always an invitation to exercise true compassion, not the misguided mercy of advocates of euthanasia. Compassion is simply the sincere effort to meet the many and varied needs of the sick until the moment of natural death. To do this is to assert, in a tangible and effective way, the dignity of the human person.

To refuse and surrender to euthanasia is to deny that human suffering has value, and to affirm that pleasure (or at least the absence of things unpleasant) is the only value worth living for. The experience of physical pain, the limitations imposed by a disability or an incurable illness, the very personal world of moral anguish are all invitations to seek a good that may be found only over and above ourselves. The word compassion comes from the Latin root meaning "to suffer with." Assisted suicide kills a human being, but there is another victim. Our humanity, the capacity to suffer with the most vulnerable members of our society, dies as well.





#### A letter to President Bush

Dear Mr. President:

In regard to your recent address to the nation pertaining to embryonic stem cell research, I thank you for your strong affirmation of life.

The mass destruction of human life should never be allowed in order for some members of society to be saved. Your decision to <u>not</u> allow funding of <u>embryonic</u> stem cell research on new lines was a courageous decision, especially in light of the over zealous scientists doing today's research.

I am concerned, however, about the decision to allow present embryonic stem cell lines to be used for research. These stem cells are from humans already killed in the name of research. It is disturbing to those of us in the pro-life movement that their destruction came about because of the easy disposal of human life in our society.

One of the questions I have regards the reaction of society if embryonic stem cell research shows a positive link between the use of embryonic cells and the cures for many diseases. What then will happen to your decision on federal funding for more research on new stem cell lines? From all the reading I have done, the use of embryonic cord blood is much more promising than the killing of at least 16 new human beings and the implantation of their embryonic stem cells into one diseased person. Have you thought through the possible outcome of today's research? If it came back to you for more federal money, would you reconsider your decision? How would you handle this dilemma?

A second concern I have is your referral to the early zygote stage of human life as "potential" human life. This wording plays into the hands of the scientific community which wants to redefine when human life begins. May I so humbly suggest that you take the word "potential" out of your vocabulary in

the future when speaking on this issue. Its use plays into the hands of those zealot scientists and others who will do anything, even lie, in order to get their research funding.

In closing, Mr. President, I want to thank you again for speaking to the nation on the worth of every human person, no matter how small. I was one of those many people with whom you shook hands before the election. I looked into your eyes and asked if you would support a Human Life Amendment to the Constitution. You looked directly at me and affirmed that you would, but you stated, "before this would happen, we have to change the minds and hearts of this nation." I have been working on this issue since 1970, and I believe too, that that is what is needed.

As we conversed maybe only a minute, I saw in your eyes a man not afraid to speak out for his convictions—one who keeps his word. You

have done this by speaking so elegantly on respect for all innocent human life. Those of us in the pro-life movement have come a long way trying to bring back a respect for human life—I finally do see a change in the hearts of our fellow Americans. I see these changed hearts in our youth. Your leadership will reinforce their beliefs and, hopefully, before another 30 years, we will indeed have our Human Life Amendment to the Constitution.

May God bless you with continuous courage and the wisdom to lead in truth, no matter what the personal cost. May He give you health, peace and happiness.
