### When aborted babies become mothers

Some scientists are attempting a new procedure in infertility treatments. They take the ovaries from an aborted baby girl and implant them into women who are sterile. When these women then have children, the child will genetically be the child of an aborted baby. Research has found that an unborn baby girl, just 12 weeks old, already has nearly all of the eggs she ever will, and the baby's ovaries would quickly mature if transplanted into an adult woman. This procedure would promote abortion more so than other types of fetal tissue research, which at times can use naturally miscarried babies, because it is felt that miscarried babies are "frequently abnormal and infected, and thus of little value for therapy or research."

#### Pregnancy rates fall

According to a report from the Centers for Disease Control and Prevention, fewer teens are having abortions and teen birth rates are falling in nearly every state. According to the report which studied 42 states plus the District of Columbia, fewer teens are getting pregnant contributing to the combination of both birth rates and abortion rates dropping nationwide. However, nearly one million teenage girls still become pregnant each year, and more than 200,000 girls have abortions. The report showed that teens aged 15 to 19 had fewer pregnancies between 1992 and 1995.

Abortion rates went up in three states (Maine, Ohio and Oregon) but fell in every other state. However, states are not required to report abortion statistics and eight states including California, Illinois and Florida did not send a report. States vary dramatically in this area, ranging from 56 pregnancies for every 1,000 teenage girls to 229 per 1,000. The decreases in pregnancy were larger for black teens than white, although black teens are still more likely to get pregnant than white teens.

# "The Heart of Abigayle Ministries"

She was a young, single woman who found herself in a situation that is all too common in these days. She was pregnant, but had little or no emotional or practical support from either the child's father or her own family.

This young woman was in crisis. She felt alone, vulnerable and confused. What was she to do? The simple answer seemed to be—get an abortion. Why not? It was legal, so how wrong could it be? Yet, while she considered this "choice," something inside told her, no! This was not right!

Mercifully, she found her way to a crisis pregnancy center. There, she received counseling, compassion and hope. With the support she received, she was able to make a decision for life—to give birth to the child she was carrying. Through the center, she also found a home. A couple opened their home to her, and she lived with them through the remainder of her pregnancy, and for some time after the birth of her daughter, whom she named Abigayle.

This true story reveals the heart of Abigayle Ministries.

Many critics of the pro-life movement have made the accusation that pro-lifers don't care about the woman. Former Surgeon General Joslyn Elders epitomized this attitude in her famous "they have a love affair with the fetus" quote. Yes, we do care about the precious little one still in the womb. But we realize that we cannot reach out to those innocent ones without reaching out to their hurting, needful mothers. This is the heart and vision of Abigayle Ministries.

We are a Christian, non-denominational, not-for-profit residential ministry for single, pregnant women from eighteen years of age and older. Our desire and intent is to provide a life option to that confused, frightened woman who may see no practical way she can choose life for her child. As our Mission Statement reads, in part, we are "dedicated to providing a Godly, safe and nurturing environment for the unwed pregnant woman and her child."

In addition to creating a loving atmosphere for the mother and baby, we are committed to helping her prepare to take care of her little one in several practical ways. The Life Skills program covers basic decision making, baby care, nutrition, parenting skills and other areas.

A major aspect of our program is education and job skills training. We endeavor to help the young woman prepare to meet the future financial needs of herself and her child.

A third and, we believe, just as important aspect is the Values portion of the program. This covers moral areas, such as chastity before marriage, human relationships and our relationship with our Creator and our God.

We realize that we cannot reach out to those innocent ones without reaching out to their hurting, needful mothers.

There are three facets to Abigayle Ministries.

First, there is the private extended living homes program. Here, we place expectant mothers in private homes with families who have opened their hearts and homes to them.

Second, there is the Group Maternity Home. We are presently renovating a facility on Nineteen Mile Rd. in Sterling Heights, that will house up to six women and their babies at a time, in addition to a resident house parent couple. The women will be able to stay here through their pregnancy; for those who choose to parent their child, they can remain for up to six months after giving birth.

The third facet of Abigayle Ministries is the Apartment Community. We have a vision for a community of small apartment buildings, which will house the single moms and their babies for up to two years, while they prepare to support themselves through education or job training.

As you can see, the vision for this ministry is very large. It has to be, because

the need is that large. To carry out this vision will require a great deal of material and financial support. In addition to that, however, it will require the greatest asset we could ask for: people. We believe that if enough people hear about Abigayle, and open their hearts to God and to these needful women and their babies, then all that is necessary will be provided.

The areas of need we have right now for the Maternity Home are: carpeting, paint, furniture, kitchen items, linens, ceiling fans, unvented gas fireplace, computers, fax machine, copier and funds to purchase other building materials. We will also be in need of monthly operating funds.

For the Apartment Community, we are looking for ten to twenty acres of land, with or without buildings. The area we are looking is Macomb County, but we will consider Oakland and St. Clair Counties.

Dear Pro-Lifer,

I am writing to update you on two very important pro-life votes that occurred in the Senate.

In February, I introduced the Child Custody Protection Act which would protect state laws requiring parental involvement in a minor's important decision whether or not to undergo an abortion. If the minor's home state has a parental involvement law, this legislation would make it a federal offense to transport that minor across state lines to obtain an abortion, unless the parents have been involved as that law requires, or the requirement has been waived by a court. Unfortunately, opponents of the bill filibustered this important legislation. Because time is limited at the end of a session, we decided to file cloture to limit debate and to try to break the filibuster. We needed 60 votes to invoke cloture. Unfortunately, the Child Custody Protection Act only received 54 votes. Even though the legislation received a majority of votes, it was not enough to break the filibuster.

While I am disappointed by this setback, I remain committed to passing this legislation. I intend to re-introduce the bill at the beginning of next session and will work to secure a vote early in the session. I will continue to work tirelessly to protect state-passed parental involvement laws.

The Senate also recently voted to override President Clinton's veto of the Partial-Birth Abortion Ban. While the veto override received 64 votes, it was 3 votes short of the two-thirds needed to override a Presidential veto.

I am deeply disappointed by the Senate's vote on both of these very important bills. I am hopeful the Senate will gain additional pro-life votes after this November's election and we will have more success next year.





# Oregon restricts payment for key pain medicine but funds assisted suicide

Oregon Medicaid has restricted payments for Oxycontin, a powerful pain medicine used for patients suffering from a number of painful disorders, according to Physicians for Compassionate Care which protested the move in a statement September 2. In the meantime, assisted suicide has been granted priority on Oregon's tax-funded health care plan.

"The state now has launched an unprecedented dosage regulation rule that will prevent Oregon doctors from being able to prescribe enough pain medication for seriously ill patients on the Oregon Health Plan," stated prominent Oregon pain care specialist, Marshall D. Bedder, M.D. Oxycontin will no longer be available in sufficient doses for treating patients seriously or terminally ill from diseases such as Lou Gehrig's disease, diabetic neuropathy. multiple sclerosis, reflex sympathetic dystrophy and several other painful disorders. The Oregon Medical Assistance Program (OMAP) now limits such prescriptions to cancer patients.

Dr. Bedder says he can no longer meet the needs for this medicine for many of his patients. Moreover, according to Physicians for Compassionate Care, OMAP's ruling is one of a series of restrictions on funding of needed care for the seriously and terminally ill enacted since Oregon's assisted suicide law was implemented last November. OMAP also attempted to restrict access by Medicaid beneficiaries to antidepressant drugs. After assisted suicide was given priority in OMAP's health care plan, over 150 needed services were denied coverage.

"This is an example of how government sanctioned assisted suicide threatens good pain management and palliative care," asserted N. Gregory Hamilton, M.D., a Portland psychiatrist and president of Physicians for Compassionate Care. "It was predicted to happen and has happened. Prescription of legitimate pain medicine for the seriously ill is being undermined by the only state that pays for assisted suicide."

### **End the Ignorance Now!**

It is impossible to become energized to fix a problem if you do not know it exists. Many black Americans do not know that over 1.3 million babies are dying from abortion each year. They do not know that about 34% of those dying are black babies, meaning some 440,000 black children die by abortion each year. Many black Americans perceive abortion as a political fight, something having little to do with their daily lives. They could not be more wrong. We must make our community see abortion as a problem in our homes. Otherwise, how can we ask that abortion be put on the agenda of critical problems to fix within the black community? How can we call it a genocide or a manifestation of white supremacist thinking, as we call drugs in our community, if it is not common knowledge that abortion has killed nearly 12 million black babies since the 1973 Roe v. Wade decision? In other words, those of us who know the truth about the enormous destructiveness of abortion have a special obligation to make abortion not an abstraction but something intensely personal to the less informed.

Government funding of organizations such as Planned Parenthood, one of the nation's largest providers of abortion clinics, reinforces the beliefs that the "solution" to black poverty is to curb black reproduction...

The problem of drugs in the black community is personal. Many of us know the men and women dying from and being destroyed by drugs. They are not just statistics to us. They are not somebody else's problem. They are part of our families. They have connections in the community and we have a leadership grappling for ways to solve the drug problem.

The aborted baby dies a violent death before even being allowed to come into

the world; typically we do not even know her name. Her mother often suffers the loss of her child in lonely silence. Her family might not even know the woman was pregnant and that a relative had existed and was killed. Our community has never gotten the chance to feel these losses consciously and collectively. Also, our media-appointed national leadership has treated the problem of abortion by consistently advocating policies that increase the number of abortions.

However, the women suffering abortion in silence, and their dead children, are a part of our community in staggering numbers. We have the job of rallying the community to stop the killing of our children. We have the job of rallying the community to find better solutions to pregnancy than killing the baby, than pitting mother against child.

But government and health care policies often discourage black women from choosing life for their babies. Our nation's policies are often based on the premise that black people's poverty is caused by their reproduction. Blaming the birthrate for poverty ignores the political, social, economic and individual reasons for people being poor.

The public funding of abortion advocacy groups at a time of drastic cuts in welfare spending is particularly significant. This willingness to facilitate abortion for poor women, who are disproportionately black, but not to address their basic needs, is strong evidence that much of the government is more interested in population reduction than in improving poor women's welfare. Government funding of organizations such as Planned Parenthood, one of the nation's largest providers of abortion clinics, reinforces the beliefs that the "solution" to black poverty is to curb black reproduction, that the fertility of black women is fearsome, and that black women do not deserve to be mothers.

#### **Emergency Contraception it is NOT**

fter sperm are deposited inside of a woman, they rapidly swim through the uterus, through the tubes, and out to the ovary. This passage takes as little as thirty minutes. If an egg awaits, fertilization then occurs immediately. One sperm enters the ovum and proceeds to unite its 23 chromosomes with the 23 female chromosomes in the nucleus of the ovum. Sperm entrance until the first cell division takes about one day. From then on, rapid cell division occurs.

For the first week of life, this new human embryo floats freely down his or her mother's tube, journeying to the womb. When one-week-old, he or she plants in the nutrient lining of the womb.

If fertilization has occurred, and if the woman takes the "morning-after" pill within a few hours or days after the "event," the hormones in the pill harden the lining of the womb. When this tiny human embryo reaches the womb, he or she cannot plant and dies. The effect of the pill, then, is to kill this tiny human at one week of life. The effect is a very early abortion.

Pro-abortion forces have labored mightily to claim that "pregnancy" does not begin until the embryo has attached to the uterus. It may well be that the mother's body is not directly affected until that time, but this human embryo is already one-week-old when this occurs. Reading and listening to the news accounts, you will hear the term "pregnancy" used interchangeably with "human life." They are not the same. It has long since been scientifically proven that human life begins at that first-cell stage. Whether you call her pregnant at conception or at implantation one week later is a mere matter of semantics. The fact of the matter is, a human life exists at the beginning and dies at one week from the effect of this pill. In fact, then, this pill is not emergency "contraception," but rather is emergency "abortion."

Reporting has correctly claimed that if the embryo has already attached, the pill apparently does no harm. It is true that the pill, then, would not cause an abortion, but it is not proven that it is

harmless. Let's not forget the tragic harvest of genital deformity in girls and boys born to mothers who were given an artificial estrogen compound, DES, back in the 1950s, while pregnant. In any case, since the baby is one-week-old when he or she plants, that is some days after she has taken the pills.

Spokeswomen for the National Right to Life Committee, among others, have made another claim, and that is that this pill stops ovulation and therefore is a contraceptive. This may be possible in a very few occasions. It would work this way: A woman has sex on Saturday night and takes the pills Sunday morning. She has sperm inside of her. She was programmed to ovulate Monday night. Without the pills, she could have conceived Monday night, because sperm can live and be active enough to fertilize for 24, and as long as 72 hours after entering her body. If she took the pills Sunday morning, it is theorized that this might block her Monday evening ovulation. If that were true, this would be a contraceptive effect. One problem here is that this mechanism has not been proven—it is only a theory. The major problem, however, is that it would occur in only a very small percentage of cases, and that in the overwhelming majority of times, she would have become pregnant within the hour after she had sex, and the pills would cause an abortion.

The reports have been correct in separating the effect of these pills from the French abortion pill RU 486. The RU 486 is taken three weeks or more after conception and two weeks or more after implantation. Its effect is to kill a developing baby after his or her heart has begun to beat. It clearly is an abortion drug and operates quite differently from a "morning-after" pill. *Conclusion:* 

In all but a very few cases, this pill does not prevent human life from beginning. What it does is kill a new human life when he or she is one-week-old. Its advocates constantly confuse their definition of "pregnancy" with the public's understanding that what is being spoken of is when human life begins and whether human life is destroyed or not.

like one which would read, "Pro-Peace, Pro-Humanity, Pro-Nuclear Holocaust." All of the slick slogans and doublespeak in the world will not change the facts.

It should not surprise us that Planned Parenthood lies in its advertising slogans because it unabashedly misleads the public in pushing its political agenda. For example, the medical director of Planned Parenthood's Washington, D.C., affiliate put in writing the false claim that during a partial-birth abortion babies are not killed by the abortionist who stabs them, but by the anesthesia administered to their mothers. This untruth, deliberately circulated by a person who, remarkably enough, still holds a license to practice medicine, caused such fear among pregnant mothers that the American College of Anesthesiologists asked Congress to hold a special hearing to refute this dangerous lie.

# Planned Parenthood and the Culture of Death

A Commentary by Michael Schwartz and Douglas R. Scott

lanned Parenthood is to the culture of death what Microsoft is to computer software. With its huge financial empire, Planned Parenthood permeates the planet with its deadly philosophy.

With money from the U.S. foreign aid program, the United Nations, and the wealthiest foundations, Planned Parenthood undermines the laws and cultures of developing countries in order to make them conform to its own anti-human vision. At the same time, Planned Parenthood convinces those in the Western World that the planet cannot survive without population control achieved by almost any means.

In the United States, Planned Parenthood is the behemoth of the abortion industry. In its own facilities, Planned Parenthood killed 153,367 children in 1996 and, with but two exceptions, has increased both its volume and market share in killing for hire every year. In fact, Planned Parenthood actively seeks to do so.

Planned Parenthood carries on the largest and most effective market promotion plan in the abortion industry through its distribution of sex aids to children. Hundreds of thousands of young girls are enticed by Planned Parenthood's so-called educational, counseling and "family plan-

ning" programs into performing sex acts in many cases becoming victims of statutory rape.

Every year, a certain proportion of these exploited girls go back to Planned Parenthood as customers. What's more, Planned Parenthood gets the federal and state governments to pay for its child exploitation activities, an achievement the common pimp on the street has yet to realize.

This is only the beginning, but the point is clear. Planned Parenthood is far out of step with the views of most Americans when it comes to sexual morays. Yet it uses taxpayer dollars to spread its horrific message to the most vulnerable and innocent among us.

The best way to judge Planned Parenthood is by comparing its rhetoric to its record. Any neutral observer can find a pattern of deception:

- Planned Parenthood claims to be profamily, yet it routinely violates the natural right of parents to guide the health and welfare of their children and to protect those children from criminal exploitation.
- Planned Parenthood claims to be prochild, yet it kills more children than any plague or tyrant.
- Planned Parenthood claims to be prochoice, yet it has successfully sued to prevent a state from giving financial support to organizations that offer choices to mothers with difficult pregnancies. This is because Planned Parenthood makes

money only when mothers have abortions, not when they have choices.

- Planned Parenthood claims to be prowoman, but it has gone to court to take away from women the right to be informed about the nature of abortion and the right to take time to reflect on their own life-or-death decision.
- Planned Parenthood claims it represents the views of most Americans, yet it has successfully sued the State of Missouri to force it to give taxpayer money to Planned Parenthood when the elected representatives of the people decided against doing so.
- Planned Parenthood claims to be a voice for minority populations, yet the methods created by eugenics advocate and Planned Parenthood founder Margaret Sanger to destroy minorities are the same ones employed by Planned Parenthood today to "help" these people. The sad reality is that Planned Parenthood has killed more minority human beings than the Ku Klux Klan could ever have hoped of lynching.
- Planned Parenthood even claims to be pro-freedom, yet it has given awards to the criminals who manage Communist China's forced abortion program and has demanded that American taxpayers subsidize that horrific cruelty.

This comparison of rhetoric to reality shows that the bumper sticker which reads, "Pro-Family, Pro-Child, Pro-Choice" is
